AS YOUR DOULA, I WILL:

- · Maintain a network of community resources

- Communicate with you throughout your pregnancy
- Encourage communication between you and your care
 provider
- Be on call 24/7 from 38 weeks of the pregnancy
- · Provide early labor support via call/text
- Provide labor support, with the exception of breaks for personal needs
- A back-up doula in the event that I am not able to attend your birth due to unforeseen circumstances
- · Strive to maintain a calm and peaceful birth environment
- · Provide support during the immediate postpartum period

CLIENT OBLIGATIONS:

In order to prepare for birth, please consider the following:

- · Complete a childbirth education and breastfeeding course
- Stay in touch during late pregnancy and early labor so that we can best determine the appropriate time for me to join you
- Tour your birth facility
- Disclose any communicable illnesses/diseases

AS A DOULA, I DO NOT:

• Perform clinical tasks including vaginal exams, or assessment of maternal or fetal well-being

- Make decisions for you, I will help gather information necessary to help you make an informed decision
- · Speak to staff on the client's behalf

• Deliver babies, if a baby arrives unexpectedly without a care provider, you, the parent(s), will be responsible for the delivery of the baby. Neither I nor Birth Boot Camp, Inc will be held liable for not providing health care.

FEES:

• A non-refundable deposit of \$_____ is due upon the signing of this agreement. This fee will reserve your estimated due date on my calendar.

• The remaining balance of \$_____ will be due by the 36th week of pregnancy and will ensure that I am on-call at 38 weeks.

• If circumstances are such that I cannot attend your birth, I will provide a qualified backup and will be responsible for payment of the backup's services. The backup will provide the same services outlined in this agreement. In the event of extraordinary circumstances, I may request a backup for relief.

• All fees are non-refundable. In the event that you fail to call to report labor has begun, or attendance of the birth is prohibited by your provider's policies, all fees are forfeited. In the care of a rapid birth, it may be impossible for me to provide these services. Fees are not adjusted for length of labor or outcomes.

• The birth will NOT be attended if fees are not PAID IN FULL as directed above.
